## **TAX CREDITS AND TAX REBATES**

#### What are tax credits?

- Tax credits are decreases in tax owed if eligible
- When the taxes are **refundable** we get that money back in a refund payment
- Payment can come in check or direct deposit

### What are tax rebates?

- Tax rebates are refunds in taxes paid
- More Coloradans received a rebate in 2021 the "Colorado Cash Back Rebate"
- Must file a state return to receive





### WHY DO TAX CREDITS MATTER?

Refundable tax credits increase financial well-being and improve health outcomes including:

- Reduced infant mortality and low birth weight
- Reduced child maltreatment
- Increased intergenerational health
- Improved outcomes across the lifecourse, and generations
- Improved educational and earnings outcomes





# **IMMEDIATE RELIEF TO FAMILIES**

2021's Child Tax Credit payments significantly reduced poverty and hunger.

- 24% decline in food insufficiency
- Financial anxiety reduced for 56% of families
- 3 million children lifted out of poverty last summer

### How did families spend their credit?

- Food
- Child care
- School-related expenses



## WHO IS MISSING OUT?

One in four eligible Coloradans does not claim their EITC

- Very low-income families
- New parents
- Grandparent caregivers
- Newcomers immigrant and refugee populations
- Non-English speaking communities
- Rural families





## **COMMON CONCERNS**

- No earnings or job needed
- Does not impact other benefits like SNAP, TANF, Medicaid or housing.
- Mixed documentation families OK
- Can use tax ID number (ITIN) to file
- Only child needs SS # for CTC
- Does not affect immigration status now or in the future



## **Libraries: Trusted Community Messengers**



### How to Support Tax Filing?

- Post flyers with QR codes linking to free tax help/info
- Know where to refer (VITA, DOR, GetCTC.org, GetAheadColorado.org, Tax Help Colorado)
- 3. Train staff on tax credits and how to access tax filing assistance
- 4. Consider hosting trained IRS volunteers during tax season
- 5. Provide resources in languages other than English

- Add a tax filing widget to your website
- If you provide computers for community use, designate one or more computer stations for "Do It Yourself" tax filing.
